## **1 ANNOUNCEMENT**

AMK in ACCR Hořice organize FIM Europe Road racing Open event "52<sup>nd</sup> year 300 curves of Gustav Havel". Event will be held on May, 17<sup>th</sup> - 18<sup>th</sup> 2014.

## **3 CIRCUIT**

Classic road racing circuit with the length of 5, 150 kilometres and maximum difference in altitude 90 metres. „Pole position“ is on the left side.

The circuit is technically difficult; there are 26 curves - 15 right and 11 left. Surface of the circuit is homogeneous asphalt with the width of 7-9 metres.

Paddock and boxes are visibly separated from the circuit. The number of mechanics in the boxes can be limited by the organizers. Arrival to the paddock is possible only before the circuit is closed. A plan of the circuit is enclosed.

## **4 JURISDICTION**

The event will be held in accordance with the ACCR General sporting code, ACCR road racing regulations and according to these supplementary regulations.

## **6 CATEGORIES AND CLASSES**

Supermono - 1-cylinder 4-stroke motorcycles to 800 cc - Filip Strnad Memorial

Twin - 2-cylinder 4-stroke motorcycles water-cooled to 650 cc, air-cooled to 820 cc

The sport event is open to all riders with the ACCR licence and to riders with appropriate licences of other National Federations (FMN). Foreign riders, holders of a licence other than ACCR, must submit during administrative inspection a starting permission, issued by FMN concerned.

All number plates and numbers must be provided by competitors themselves. Czech riders use their permanent numbers; organizers assign numbers to the foreign riders that will be mentioned in the list of approved riders. In case more riders require the same number organizers will decide. There is a qualifying limit for the Supermono and Twin categories.

## **7 NUMBER OF RIDERS ALLOWED**

The maximum number of riders allowed is following:

In case of a small number of riders in a certain category organizer reserve the right to unite the classes if possible, however, the ceremony would be for each class.

## **8 ENTRIES, ENTRY FEE**

Entry form must be approved by the rider's FMN (starting permission) and must reach the organizers **not later than April, 25<sup>th</sup> 2014 to 24:00**. Entry forms received after the deadline may not be accepted. By sending the entry form to organizer riders are obliged to follow the Supplementary regulations and necessary changes. Not complete entry forms will not be accepted. Organizer does not confirm received entry forms. The organizer reserves the right to refuse any entry form. List of received entry forms and subsequently the list of accepted riders will be published after the deadline on at organizer's websites: <http://www.amkhorice.cz/cz/zavody/300-zatacek/startovni-listina/>.

Riders who wants to start in two or more classes always pays the higher entry fee.

Foreign riders have to pay entry fee in cash during administrative inspection.

## 9 ADMINISTRATIVE AND TECHNICAL INSPECTION

Riders who do not comply with the schedule for administrative and technical controls will not be allowed to take part in the event.

All motorcycles must be checked by the Technical Stewards during technical inspection according to schedule as follows.

Administrative inspection will be held in the administrative building ATC:

Technical inspection will be held in front of the administrative building ATC:

Riders are obliged to come to Technical Inspection and submit for checking required riders equipment, confirmed entry form/starting permission, licence and technical documentations. In a case of accident the technical checking must be repeated.

**A compulsory briefing for all the riders who will be participating for the first time in the current Championship or season will be held on Friday 16th at 07:00 pm at start/finish line area.**

**Failure to attend the briefing in full will result in disqualification from the event. A waiver can be granted to a rider by the Jury.**

All newcomers are required to wear a reflexive waistcoat during the Saturday qualification practices. Waistcoats will be supplied by the Club during the signing-on sessions.

The paddock in the area of ATC "U Věže" will be open on Thursday, May 15<sup>th</sup> 2014 and on Friday, May 16<sup>th</sup> 2014 from 8:00 am to 24:00 pm. Every participant must follow the instructions of the officials and organizers. All riders must be in the paddock on Saturday, May 17<sup>th</sup> 2014 by 8:00am at the latest! The circuit will be closed at 8:00am and the entrance to the paddock will not be possible then.

It's strictly forbidden to ride a motorcycle on the circuit outside the official practice time! Rider must complete a total of at least 5 laps during the qualification to be classified for the race. The schedule is preliminary and it can be changed in case of need and according to the number of riders in each category.

## **12** PRIZES

Prize money will be paid an hour after the results will be announced. Pick them up in the Secretariat (administrative building). The prize money is fully dependent on the official results. Rider must be classified in the race. In case there are less than 10 riders in the certain class rider will get only 50% of the prize money. In case there are less than 5 riders in the certain class, no prize money will be paid.

First three riders in each category will be required to take part in a short ceremony to be held in front of the Grandstand to acclaim and garland the winners. Winner of each category will hear the appropriate national anthem. Not picked-up prize money forfeits to the organizer.

## **13** PROTESTS

All protests must be done in accordance with the ACCR Disciplinary Code and accompanied by a fee of 5.000 CZK / 200 EUR.

## **14** DRUG AND ALCOHOL TESTING

There will be random tests for presence of alcohol and narcotics during the sport event.

## **15** FUEL

Used fuel must be in accordance with article 2.10 of the FIM Technical Rules for road racing motorcycles. Petrol station is available in the city.

## **16**     **INSURANCE**

In accordance with the article 110.1 of the ACCR Sporting Code, the organizer's liability insurance and responsibility of riders competitors and officials, in case of an accident caused to the third party during the whole sport event is in the responsibility of the organizer.

The organizer is obliged to arrange an insurance of participants for damage caused by his motorcycle during the sport event. The payment of this insurance is included in the entry fee. The number of the insurance contract: 0013869817 - via insurance brokerage company RENOMIA a.s.

The organizer disclaims all responsibility for damage to motorcycle, its accessories and components arising out of an accident, fire or other cases.

By endorsing the application form for entry, the FMN of the rider certifies that the rider is insured in accordance with the FIM Europe requirements.

## **17**     **LIMITATION OF LIABILITY**

Apart from the requirements of the ACCR Sporting Code, participants (incl., but not only: competitors, riders, mechanics, guests etc.) by participating renounce all rights of appeal against the organizer, his representatives or agents by arbitration of before a tribunal or any other manner not foreseen by the ACCR Sporting Code for any damages for which they could be liable in consequence of all acts or omissions on the part of organizer, his officials, representatives or agents in the application of these regulations or contributed to or arising out their actions.

Jury reserves the right to modify these Supplementary regulations and the timetable of the event by bulletins published later.

## **18**     **PARKING AND THE EXIT FROM THE TRACK**

The paddock is a part of the accommodation facilities ATC "U Věže" AMK Hořice. Area of the paddock is fenced and at the time of the event is closed to the public - only riders with their teams are accommodated in the camp and spectators are allowed to enter the paddock only with the valid ticket. Riders and members of their teams are obliged to follow the organizers' instructions. Each rider is responsible for all members of the team. In case of breaking the rules and organizers instructions, riders may not be allowed to take part in the practice/race. Night piece is from **11:00pm to 7:00am!!!** Riders will ride to the starting line through the access road from the paddock. Return to the paddock is through "Cesta Legii" and the side entrance. Rider will slowly pass one more lap after the end of a practice/ race and will be diverted to the previously mentioned "Cestu Legii" and admit to the paddock by the side entrance.
