Dear Team Manager,

A very exciting racing season has come to an end only a week ago and with this letter we wish to invite you to start **2014** enrolments to **eni FIM Superbike World Championship**.

Please find below new enrolment procedures.

**SBK & WSS FIM Championships:**

1. **Pre-application** form is attached. Please do fill it in to the best of your knowledge available at this stage and send it in electronic format using the function "SUBMIT BY EMAIL". All the fields of the form are compulsory.
2. The pre-applications should be submitted by **15 November 2013** at latest.

\*please note, submitting pre-application form does not guarantee your team/riders enrolment to the Championship.

3. By **22<sup>nd</sup> of November** the organizer will inform you via email if your application has been accepted in order to proceed with the registration / or your application is on a standby till further notice.

\*applications on standby will be reviewed by **10<sup>th</sup> December 2013** and the teams will be notified about the final decision thereafter

4. Once agreed with the partnership conditions, team will be requested to pay the amounts specified below (no later than **01 December 2013**) to guarantee your team & riders enrolment to the 2014 WSBK Championship.

- a. **SBK** deposit: €15.000, 00 per rider (will be deducted from the 1<sup>st</sup> instalment of the tires fees)
- b. **WSS** entry fee €10.000, 00 per rider.

\*only having received holding deposit, the enrolment to the Championship is final & the team/riders will be added to the Provisional 2014 Permanent Entry list

5. No refund of a deposit or entry fees will be accepted after **1 December 2013** in case of team or rider withdrawal.
