## **1 ANNOUNCEMENT**

AUTOMOTO club in ACCR Hořice organises a road racing event “55<sup>th</sup> year 300 curves of Gustav Havel” held in May, **20<sup>th</sup> – 21<sup>st</sup> 2017**.

This event is entered in the FIM Europe and ACCR calendar under the following numbers: **FIM Europe 10/223** and **ACCR 210/402**.

## **3 CIRCUIT**

Length: 5 150 metres

Width: 7 - 9 metres

Maximum difference in altitude: 90 metres

The circuit is technically difficult; it has 26 curves - 15 right and 11 left. Surface of the circuit is homogeneous asphalt. Direction of the race is clockwise. Pole position is on the left side.

Boxes are visibly separated from the circuit. The number of mechanics in the boxes can be limited by the organizers. A plan of the circuit is enclosed.

Paddock is in the middle of the circuit and therefore the arrival is possible only before the roads are closed (Saturday and Sunday roads are closed at 08:00 at the latest).

## **4 JURISDICTION**

The event will be held in accordance with the ACCR General sporting code, ACCR road racing regulations and according to these supplementary regulations.

## **6 CATEGORIES AND CLASSES**

Supermono	- 1-cylinder 4-stroke motorcycles to 800cc
Twin	- 2-cylinder 4-stroke motorcycles water-cooled to 650 cc and air - cooled to 820cc
SP 125	- „Martin Turna Memorial“
GP 125	- „Hořice Cup“
CRR 250	
600 (SSP,SST 600)	- „AUTO IN Cup“
1000 (SBK,SST 1000)	- „ORT Nový Bydžov Cup“

The sport event is open to all riders with an ACCR national licence or higher and to riders with appropriate licences of other National Federations (FMN). Foreign riders, holders of a licence of other than ACCR, must submit a starting permission during the administrative inspection.

All number plates and numbers must be in accordance with the ACCR Technical rules (2.3.20) and must be provided by competitors themselves. Czech riders use their permanent numbers; organizers assign numbers to the foreign riders that will be mentioned in the list of approved riders. In case more riders require the same number, organizers will decide. Starting numbers must be visible from the front part and both sides of the motorcycle.

There is a qualifying limit for the Supermono and Twin categories.

## **7 NUMBER OF RIDERS ALLOWED**

The maximum number of riders allowed is following:

Up to 600 (SSP, SST 600) + Over 600 (SBK, SST 1000)	
Practice: 40	Race: 36
(125 SP, 125 GP, 250 SP, 250 GP, Supermono, Twin)	

In case of small number of riders in certain category organizers reserve the right to unite the classes if possible, however the ceremony would be for each class.

## **8 ENTRIES, ENTRY FEE**

The official entry form must be approved by the rider's FMN (starting permission) and must reach the organizers not later than **April, 28<sup>th</sup> 2017 to 24:00**. Entry forms received after the deadline may not be accepted. By sending the entry form to the AMK Hořice riders are obliged to follow these Supplementary regulations and necessary changes. Entry forms that do not contain required information will not be accepted. Organizers do not confirm received entry forms. Organizers reserve the right to refuse any entry form. List of received entry forms and subsequently the list of approved riders will be published after the deadline on [www.amkhorice.cz](http://www.amkhorice.cz).

Entry fee (included of liability insurance):

- Every other start	90 €

Riders who start in two or more classes always pay the higher entry fee as a basis. **Foreign riders pay entry fee in cash during the administrative inspection.**

## **9 ADMINISTRATIVE AND TECHNICAL INSPECTION**

Riders who do not comply with the schedule for administrative and technical controls will not be allowed to take part in the event.

All motorcycles must be checked by the Technical Stewards during technical inspection according to the schedule as follows.

Administrative inspection in the administrative building ATC:

Technical inspection in front of the administrative building ATC:

Riders are obliged to come to the Inspections and submit for checking: required riders equipment, confirmed entry form / starting permission, licence and technical documentations. In case of accident the technical checking must be repeated.

<p><b>A compulsory briefing for all riders who will be participating for the first time in the current Championship or season will be held on <u>Friday, May 19<sup>th</sup> at 8pm</u> at the start/finish line area.</b></p> <p><b>Failure to attend the briefing in full will result in disqualification from the event. A waiver can be granted to a rider by the Jury.</b></p>

All newcomers are required to wear a reflexive waistcoat during the Saturday qualification

practices. Waistcoats will be supplied by the Club during the signing-on sessions.

The paddock in the area of Autocamp “U Věže” will be open **on Thursday, May 18<sup>th</sup> 2017 and on Friday, May 19<sup>th</sup> 2017 from 08:00 to 24:00**. Every participant must respect the instructions of the officials and organizers. All riders must be in the paddock on Saturday, May 20<sup>th</sup> 2017 by 08:00am at the latest! The circuit will be closed at 08:00am and the access to the paddock will not be possible then.

Space will be allocated by the organizer and its appointed agent based on the information given to Zdeněk Brabec, e-mail: [zbrabec@seznam.cz](mailto:zbrabec@seznam.cz). The paddock parking position will be made by the organizer and its appointed agent and the decision will be final. Teams and / or competitors will receive notification of their paddock parking position on arrival.

It's strictly forbidden to ride a motorcycle on the circuit outside the official practice time! Rider must complete **a total of at least 5 laps** during the qualification to be classified for the race. The schedule is preliminary and it can be changed in case of need and according to the number of riders in each category.

## **12 PRIZES**

Prize money will be paid an hour after the results will be announced. Riders can pick them up in the Secretariat (administrative building). The prize money is fully dependent on the official results. Rider must be classified in the race. In case there are less than 10 riders in certain class rider will get only 50% of the prize money. In case there are less than 5 riders in certain class, no prize money will be paid.

First three riders in each race will be required to take part in a short ceremony to be held in front of the Grandstand to acclaim and garland the winners. Winner of each class will hear the appropriate national anthem. Not picked-up prize money forfeits to the organizer.

### **13 PROTESTS**

All protests must be done in accordance with the ACCR Disciplinary Code and accompanied by a fee of 5.000 CZK / 200 €.

### **14 DRUG AND ALCOHOL TESTING**

There will be random tests for alcohol and presence of narcotics during the sport event.

### **15 FUEL**

Used fuel must be in accordance with article 2.10 of the FIM Technical Rules for road racing motorcycles. Petrol station is available in the city.

### **16 INSURANCE**

In accordance with the article 110.1 of the ACCR Sporting Code, the organizer's liability insurance and responsibility of riders, competitors and officials, in case of an accident caused to the third party during the whole sport event is in the responsibility of the organizers.

The organizer is obliged to arrange an insurance of participants for damage caused by the motorcycle during the sport event. The payment of this insurance is included in the entry fee. The number of the insurance contract: **7721016822** - via insurance brokerage company PLATINUM Consulting s.r.o..

The organizer disclaims all responsibility for damage to motorcycle, its accessories and components arising out of an accident, fire or other cases.

By endorsing the application form for entry, the National Federation of the rider certifies that the rider is insured in accordance with the FIM Europe requirements.

### **17 LIMITATION OF LIABILITY**

Apart from the requirements of the ACCR Sporting Code, participants (incl., but not only: competitors, riders, mechanics, guests etc.) by participating renounce all rights of appeal against the organizer, his representatives or agents by arbitration or before a tribunal or any other manner not foreseen by the ACCR Sporting Code for any damages for which they could be liable in consequence of all acts or omissions on the part of organizer, his officials, representatives or agents in the application of these regulations or contributed to or arising out their actions.

Jury reserves the right to modify these Supplementary regulations and the timetable of the event by bulletins published later.

## **18 PARKING AND THE EXIT FROM THE TRACK**

Paddock is a part of the accommodation facilities Autocamp “U Věže” AMK Hořice. Area of the paddock is fenced and at the time of the event is closed to the public - only riders with their teams are accommodated in the camp and spectators are allowed to enter the paddock only with the valid ticket. Riders and members of their teams are obliged to respect the organizer’s instructions. Each rider is responsible for all members of the team. In case of breaking the rules and organizers instructions, riders may not be allowed to take part in the practice/race. Night piece is **23:00 to 07:00!!!** Riders ride to the starting line through the access road from the paddock. Return to the paddock is through the “Cesta Legií” and the side entrance. Rider slowly passes one more lap after the race and is diverted to the previously mentioned “Cestu Legií” and admits to the paddock by the side entrance.
