4. REGULATIONS

The organizer retains the right to inform all competitors/drivers about supplements to the regulations and/or to publish special instructions to ensure the correct running of the event by means of official bulletins. These bulletins have the same effect and authority as these supplementary regulations.

The event is run in accordance with the following rules regulations and all competitors and drivers taking part in the Event must abide by them:

5. PRELIMINARY TIMETABLE

Closing of entries: 21 August 2020

Practice: The use of the circuit outside the times officially assigned for the respective category is

prohibited and will be penalized up to exclusion from the event.

Results: Will be posted on the official notice board after each practice/race session. Results will be

available only electronically.

Parc Fermé: In the scrutineering bay.

6. ENTRIES

Entries must be sent to the organizer by the entry closing time. Entries can be sent by email, duly signed original of the entry form must be presented during the administrative checks. Entries may be accepted after the deadline only in exceptional cases. In this case the entry fee will increase by 50%, or by 100% if the entry is on the day of scrutineering. All entries will be confirmed by email only.

The following documents must be submitted with the entry form: copy of competitors' and drivers' license and starting permission.

Competitors can send those documents to the Organizer by email or submit during the administrative checks. The Organizer will not provide any copy service to the participants.

7. ENTRY FEE

- a) Entry fee (in a reduced amount) can be paid in advance by bank transfer to the organizer's account. Payment must be credited to the organizer's account by Thursday, August 27. Payment instructions will be received by the competitor from the organizer on request.
- b) Entry fee in full amount are payable during the administrative check.

The track length is 5,403 meters, obligatory direction of the race: clockwise.

10. DRIVERS' BRIEFING

There will be no organized drivers' briefings. Competitors will receive the instructions during the administrative checks or via e-mail.

12. STARTING PROCEDURE

12. 1. Standing start

When the cars come back to their respective grid positions and no board is raised, the first red light will be switched on (red lights illuminated in pairs) which is the five second signal, the second red light signifies the four second signal, the third one the three second signal, the fourth one the two second signal and the fifth one the one second signal.

Between 0,2 and 3 seconds after the one second signal appears, extinguishing all red lights will start the race.

12. 2. Rolling start

Safety Car will be used as an official leading car for the rolling start.

13. PRACTICE

Only cars, which have been passed by the scrutineers, will be allowed to take part in the official practice.

15. PIT LANE SPEED LIMIT

There is a speed limit of 60 kmh in the pit lane.

16. Race

The race will not be suspended in case of rain unless the circuit is blocked or it is dangerous to continue.

16.1. Endurance race D4 + D5:

The pit stop time for cars which refuel will be 90 sec, and after that they have to stay in the refueling zone min. 30 sec., which will be controlled by the judge of fact. The penalty for the infringement of this rule is the same as for the infringement of the pit-stop regulations.

17. STOP & GO

Stop&Go penalty area is in the front of the control tower.

18. PADDOCK AND PITS

Only persons and cars holding a valid paddock pass will be admitted to the paddock.

Pits can be booked in writing with the organizer. Priority will be given to BOSS GP competitors and endurance race participants. The price for one pit is: 21.000 CZK (840€) / event, and is payable by credit card only. Keys will be handed over upon a deposit of 2.000 CZK. In case of any damage in the box the deposit will not be refunded.

As far as possible garage doors must be kept open, with the exception of the Endurance race, when competitors not participating in the race must keep the garage doors toward the pit lane closed.

20. Timekeeping

Timekeeping will be using AMBTranx260 transponders. Transponders will be handed over after the sign on in the timekeeping room (2nd floor No. 301/303) upon a valid driver's license. In case of loss and/or any harm driver will pay 8.000 CZK / 320€ in cash.

21. Driving

Each driver must use the timing transponder supplied by the organizer or nominated timekeepers throughout the Event. All competitors are themselves responsible for obtaining this transponder, at their own expense, and for the correct installation and functioning thereof. This transponder must be installed in strict compliance with the relevant instructions.

22. Prize giving:

The participation of other persons on the winner's podium, except winning drivers is forbidden. <u>Trophies will not be presented personally due to covid-19 measures.</u> Price giving for D2, D4 and D5 will be on the podium immediately after each race. The first 3 classified drivers have to attend the price giving ceremony.

23. Covid-19 measures

The number of team members must be kept to the minimum necessary.

Wearing a nose and mouth protection in closed areas (administrative checks, race tower) is compulsory by the competitors / participants.

Participants are encouraged to keep a distance of 2 meters and avoid crowding.

The contacts of persons from different teams has to be limited to minimum or avoided.

Each competitor is responsible for cleaning, disinfection and ventilation of the boxes / tents.

Sufficient own disinfectants must be kept in stock by the participants.

Participants must comply with all resolutions, measures and recommendations of the Government of the Czech Republic, the Ministry of Health of the Czech Republic, the public health authority or other state administration bodies related to the prevention of the spread of COVID-19.

Participants are prohibited from entering areas reserved for circuit employees.

Participants are required to use only reserved toilets.

Circuit employees are entitled to deport a participant with symptoms of COVID-19 from the circuit premises. In such a case, the person concerned must leave the circuit premises immediately.

The temperature of the participants can be measured with a non-contact thermometer. In case of temperature higher than 37 ° C or rejection of this measurement, the participant is obliged to leave the circuit premises immediately.

24. Limitation of liability

Competitors by participation in the Event declare that they accept the requirement of these Supplementary Regulations and regulations described in Art. 4. of these Supplementary Regulations and they will strictly abide by them and that they recognize the FAS AČR as the only competent jurisdiction with the exception of the provisions of the FIA ISC.

Responsibility:

Participants (in particular: competitors, drivers, mechanics, guests, etc.) understand and acknowledge that the Event is an activity with increased risk of damage or damage to property or health. Participants take part in the Event at their own responsibility and at their own risk. They carry sole civil and criminal legal responsibility for any damage or injury caused by them or by the vehicle they use. Participants are obliged to act during the Event in a way that does not cause harm and/or damage to health, property, nature or the environment and to behave considerably to other participants, the organizer, the FAS ACR, the owner of the race track, as well as to any person involved in the Event.

Liability Renunciation

Participants (incl., but not only: competitors, drivers, mechanics, guests, etc.) and/or their agents waive any direct or indirect claims and/or demands against the Organizer, FAS ACCR, owner of the racetrack, as well as against anybody, who is involved in the Event.

Participants (in particular: contestants, riders, mechanics, guests, etc.) waive for themselves and their persons closely related any direct or indirect requirements and / or claims arising from the Event, except for those which cannot be quitclaimed, to the organizer, FAS ACR, the owner of the race track, as well as against any person involved in the Event. Participants hereby accept victim's risk against the organizer, the FAS ACR, the race track owner, and any person involved in the Event consisting in harm and / or damage to health or property arising from or in connection with the Event.

Bulletins

The organizer reserves the right to modify these supplementary regulations and the timetable of the Event.

25. ADDITIONAL REGULATIONS

25.1. Passes

Passes must be worn and be visible at all times. Each competitor will receive per one racing car: one personal pass and one car pass for each <u>driver, 2 paddock parking passes, 4 pit lane passes and 1 pit wall pass</u>. Private cars (except service cars) are not allowed to park in, nor to enter the paddock area. Access to the pit lane is restricted to authorised personnel only. Access to the pit lane and pit wall is not allowed to persons less than 16 years age.

25.2. Advertising.

All matters concerning the advertising are governed by the relevant articles of the national and international regulations and of the Sporting Regulations Circuits 2020.

25.3. Insurance

The organizer is insured for the third partly liability, according to the insurance policy concluded with Generali Pojišťovna in the amount of 70,000.000 CZK. Competitors are insured for the third partly liability, according to the insurance policy concluded with Generali Pojišťovna in the amount of 70,000.000 CZK with participation of 5.000 CZK. Damages up to 5.000 CZK has to be paid by the competitor. Insurance is not covering damages among drivers themselves. Every driver must have a personal accident insurance.

25.4. General paddock organization

There may be only teams and Event participants' service vehicles inside the paddock. The paddock is open for setting up only on Wednesday 2 September from 20h00 to 21h00 and on Thursday 3 September from 7h00 to 21h00. There must be a car pass visibly placed in each vehicle. All cars without visible pass, overstaying in the paddock or parking on the route in the paddock will be towed away. Unauthorized parked vehicles will be towed away from the paddock, and the penalty of 5.000 CZK will be payable by the offender! No parking is allowed on all connection- and rescue-roads in the paddock. Competitors must clear and leave the pits and paddock by 18:00, Sunday 6 September. Competitors and/or all the participants must respect the traffic signs in the paddock and the traffic laws are valid in the entire paddock. Maximum speed in the paddock is 20 kmh. No parking is allowed on all connection- and rescue-roads in the paddock. Free movement of children less than 15 years of age on skates, skateboards, bicycles, motorcycles or minibikes is prohibited. Parents are liable for their children. All the participants must keep the environment clean and avoid pollution. Cleaning of vehicles with fuel or other solvents is prohibited. The ground in the paddock cannot be damaged from oil, fuel or other liquids as well as from tent-fortifications. All waste must be put into the waste-bins; used oil must be put into special tanks. Running of any commercial and business activity on the premises of Automotodrom Brno is only possible on the basis of a written contract with Automotodrom Brno, a.s

25.5. Firefighting regulations

It is forbidden to smoke and manipulate with an open fire in the all the non-smoking areas. Smoking and open fire is forbidden from the signalling wall up to white line behind the garages (towards paddock). Any violations will be penalised.

25.6. General

All details not included in those regulations will be decided in accordance with valid regulations of ISC and NSC. The participation of all participants in the Event confirms that they are aware of these regulations and they are prepared to observe them without reservations. Equally they are prepared to follow the instructions of the members of the organization committee, nominated officials and information published on the official notice board. In the case of the difference in the translated versions of this Supplementary Regulations the Czech version will take precedence.

25.7. Protests

The protest fee is set to 18.000 CZK (720 €) payable in cash. The appeal fee is set to 39.000 CZK (1560 €) payable in cash
