ARTICLE 4 INSURANCES

In compliance with the legal prescriptions, the Organiser has contracted one or several insurance(s) guaranteeing the following risk(s)

4.1 Liability Insurance

4.1.1 ACCR entered into an agreement with the insurance company Allianz pojišťovna a.s., through PLATINUM Consulting, s. r. o. insurance policy No. C550012623 on liability insurance of the organizer for damage caused to another in connection with the organizer of go-kart races up to the amount of CZK 11,000,000.

4.1.2 Part of the framework insurance contract is the insurance of participants' vehicles against damage caused to third parties up to the amount of CZK 11,000,000 per participant. The insurance does not cover damage caused by event participants mutually among themselves. The organizer undertakes to provide this insurance for all participants, with the exception of those who administrative receipts will prove that they have

taken out their long-term insurance covering damages caused to closed track.

4.1.3 Organizer and participant insurance is negotiated with an integral deductible of CZK 5,000, i.e. damages up to CZK 5,000 will not be covered and damages above this limit will be covered without the participation of the insured.

ARTICLE 7 SUPPLEMENTARY CONDITIONS

1. From Wednesday to Sunday vehicles will only have access to the Paddock in the morning to 09:00 after this time paddock gates will be closed to after the action on the track, it is forbidden to drive in the Paddock with any Car, Van or Lorry without a proven Promotors pass, even when the gate is open and not manually guarded, A fine will be inflicted by the Stewards on any person not respecting this rule

2. Personal passes must be presented at any time and no one will be readmitted in SERVICING PARK, or PADDOCK - AREA. Personal passes that are not worn by their holders will be confiscated. Lost passes will not be replaced by the Organise or a fee of 70.00€ are to be paid. Vehicle passes are only valid if they bear the registration number of the vehicle
