

# **General Terms and Conditions of Contests on Instagram**

## **I. Introductory Provisions**

1. The organiser of the contests held on the Instagram page “cze.mgp,” accessible at [www.instagram.com/cze.mgp](https://www.instagram.com/cze.mgp), is the association Autoklub of the Czech Republic, with its registered office at Opletalova 1337/29, 110 00 Prague 1 – Nové Město, Company ID No.: 00550264 (hereinafter referred to as the “Organiser” or “Autoklub of the Czech Republic”).
2. None of the contests published on the Organiser’s Instagram page is in any way sponsored, supported, or administered by Instagram (Meta Platforms), nor is it otherwise associated with Instagram. Therefore, Instagram (Meta Platforms) bears no responsibility for any of these contests.
3. There is no legal entitlement to prizes, and prizes are not enforceable in court. The Organiser reserves the right to modify the terms and conditions or the prizes of a contest during its course or cancel the contest altogether without compensation. The Organiser is not liable for any technical issues associated with participation in the contest.
4. By entering the contest, the participant agrees to these rules.

## **II. Eligibility and Contest Process**

1. The contest is open to individuals aged 18 and older who are permanent residents of the European Union and have a delivery address within the EU. Employees of Autoklub of the Czech Republic are not eligible to participate.
2. To validly enter the contest, participants must meet the conditions specified in the individual contest post. Failure to comply may result in disqualification.
3. If the contest requires a comment to be posted, only one comment per user will be considered for entry.
4. The duration of each contest is stated in the respective post.
5. Prizes are not subject to any purchase contract. The Organiser is not liable for defects in performance. Winners are not entitled to claim or return the prize.

## **III. Winner Selection**

1. The method of selecting winners is determined by the Organiser. Winners will be announced no later than 2 days after the contest has ended. Their usernames will be published in the comments under the contest post.

2. The prize will be sent to the winner either via delivery service or by email, depending on the type of prize, no later than 30 days after the end of the contest.
3. By entering the contest, participants agree that, in case of winning, they may be asked to provide their personal data and delivery or email address for the purpose of sending the prize. These data will be used solely for the one-time dispatch of the prize and will not be otherwise processed. Winners must submit their personal data no later than 7 days after being contacted; otherwise, the prize will be awarded to another participant.

#### **IV. Personal Data Processing**

1. Unless otherwise stated by the Organiser for a specific contest, the Autoklub of the Czech Republic processes the username during the contests. In the case of winners, the following data are processed: username, name and surname, delivery address, phone number, email address, and prize details.
2. The purpose of processing is to ensure compliance with the contest rules and the delivery of prizes to winners. After the contest has ended, all personal data will be deleted. The data are not transferred to third parties, except for the delivery service used to send the prize.

**These rules are effective as of 24 June 2025.**
