The receipts for payment of the entry fee will be handed over at the administrative checks.

As the entry form from the Driver and the confirmation of the acceptance from the organiser is considered as a contract, the Driver, not coming to the Competition, has to apologise giving the reason as soon as possible.

4.5 Entry fees may be refunded only:

- to candidates who are not accepted,
- in the case of the Competition not taking place,
- if the Competitor withdraws his entry no later than the Monday before the Competition. If the withdrawal is announced to the organiser between that Monday and the opening of the administrative checking, 50 % only of the entry fee will be refunded.

7. INSURANCE

7.1 Insurance coverage of the organiser

The Autoklub CR concluded with "Allianz Insurance, a.s.", through the company PLATINUM Consulting s.r.o., the frame insurance contract No. 550012623 on insurance of liability of the organiser for damage caused to the others in connection with a sport enterprise up to the sum of CZK 50.000.000.

7.2 Insurance of competitors and drivers

The part of the frame insurance contract No. 550012623 is insurance of cars of the participants against damages caused to third persons up to the sum of CZK 50.000.000 per one insurance event with co-participation of CZK 5.000. Any damage below CZK 5.000 will be paid by the driver who caused the damage; damages above CZK 5.000 will be paid by the insurance company without any co-participation of the insured. However, the insurance does not cover liability for the damages caused by event participant that the competitors cause each other in the course of sport event.

7.3 Each driver is obliged to conclude his personal injury insurance and to present a proof on request the administrative checking. The insurance of foreign drivers must include coverage of costs for possible medical treatment in the CR.

8. NOISE CHECKING

For all cars a limit of 100 dB (RB 110 dB) is imposed.

9. PRIZES AND CUPS

The prize-giving ceremony, which will take place in front of the VIP building, will be held immediately after the finish of each final. Drivers who finish in the top three must attend this ceremony. Failure to attend the ceremony will result in losing the prizes.

10. OTHER INFORMATION

10.1 Competitors' Liaison officer

The Competitors' Liaison Officers will be recognisable by orange waistcoat with the inscription "COMPETITORS' LIAISON OFFICER". You will find a detail on Sportity.

He may be reached: in the headquarters area and in the parking lot of racing machines.

10.2 Protests - Appeals

Protests must be submitted in accordance with Art. 13 of the Code.

All protests must be in writing and must be forwarded to the Chairman of the Stewards. In the absence of the Chairman of the Stewards, such protests shall be delivered to one of the other stewards, or in their absence, to the race director or the clerk of the Course. The protest must be accompanied by the amount of 15.000 CZK. If the protest requires the dismantling and reassembly of various elements of the car, a deposit of up to 250,000 CZK is required from the protesters.

The competitors have the right to appeal, in accordance with Art. 15 of the Code. The amount of the deposit in case of appeal is 30.000 CZK.

Appendix 1

- 1) Driver and all members of his team have to wear appropriate tickets all the time, they will receive these tickets (1+4) at the administrative checking. A breach of the behaviour rules in the paddock may result in a fine of up to CZK 10,000.
- 2) Vehicles that are not the transporter of the racing special, or service facilities, or personal vehicles of team escorts, will be parked during the racing weekend only in the spectator parking lot opposite the Orlen.
- 3) Motorhomes and trucks and trailers will be parked only on a place assigned by the organizer to a specific racing team.
- 4) The organizer allows the use of extension cables and their accessories only with a valid inspection or manufacturer's certification.
- 5) It's forbidden to use any other vehicles (motorbikes, quads, segway etc.) in all areas under the fine of CZK 20.000. The penalty amount and its collection are at the discretion of the Clerk of the Course.
- 6) During the entire race weekend, the use of private drones is prohibited under a fine of CZK 20.000.
